2. United States History Vocabulary

- **Founding Fathers** (noun) – *the group of revolutionary leaders that established the United States.*
- **checks and balances** (noun) – *a system of government where the different branches (executive, legislative, judiciary) have powers to counterbalance the other branches to prevent them from becoming too powerful.*
- **The Great Depression** (noun) – *a worldwide economic recession caused by the Wall Street stock market crash in 1929.*
- **red scare / McCarthyism** (nouns) – *a fear of communism or other left-wing ideologies / a campaign led by Senator Joseph McCarthy that accused many people of subversion or treason for their supposed links to communism.*
- **Civil Rights Movement** (noun) – *a campaign to abolish the segregation, discrimination, and disenfranchisement of black people in the 1950s and 1960s.*
- **world / global policeman** (noun) – *a powerful state that seeks global hegemony or the right to intervene in other countries.*
